

# Shorewood Country Club Dues Pricing

**\*\*FIRST 12 MONTHS OF MEMBERSHIP NOT INCLUDING TAX\*\***

Family Golf Membership	\$3000/year	or	\$250/month
Single Golf Membership	\$2000/year	or	\$167/month
Non-Resident Single	\$1750/year	or	\$146/month
Junior Golf Membership	\$1020/year	or	\$85/month
High School Golf Membership	\$500/year		
Social Membership	\$300/year	or	\$25/month

After 12 months, the social membership will go to \$523/year each year following.

Prices are subject to change based on the Annual Membership Meeting approval on the third Tuesday in November each year.

## **Benefits:**

- First to receive SCC's new rate of \$2,000 annual dues
- No-step program, this rate is not introductory or by any other means a "base" or "promotional" rate
- Guaranteed rate for 3 years as SCC looks to drive membership growth of 200+ golfing members
  - Any due % increase voted on during annual meeting will be applied, range of 0-3% the past 7 years
  - After 3 years a new equilibrium rate will be set for all members. Forecast is that at 185 golfing members would be \$2,500 annually or \$2,000 annually at 210 members

## **Restrictions:**

- This is currently only for 2024 new/returning members. No consideration has been made whether to extend this option for 2025
  - As such, current members that resign for 2024 and return in 2025 will be responsible for dues at the step they left SCC on
- Returning members must be removed from a golf membership for 12 months to be eligible
  - This is not an introductory offering, which requires 3 years absence
